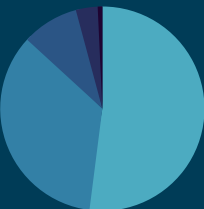

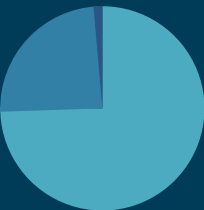
# Financials
